## Website Terms and Conditions

---

- 1.1. EBC Financial Group (SVG) LLC (Company Registration No. 353 LLC 2020) whose registered office is located at First Floor, First St. Vincent Bank Ltd Building, James Street, Kingstown, St Vincent and the Grenadines (hereinafter referred to as “EBC”, “we” or “us”) is the owner of [www.ebc.com](http://www.ebc.com) and [www.ebcfin.com](http://www.ebcfin.com) (hereinafter referred to as “this Website”, “our Website” or “EBC’s Website”), with all rights reserved.
- 1.2. All access to and/or usage of this Website is subjected to and governed by these Website Terms and Conditions (“Terms and Conditions”). The information on this Website is not directed at:
  - 1.2.1. the residents of the countries described in the pop-up compliance disclosure shown when you enter [www.ebc.com](http://www.ebc.com) or [www.ebcfin.com](http://www.ebcfin.com); and
  - 1.2.2. any person in any country or jurisdiction whereby such distribution or use would be contrary to local statutes or regulations.
- 1.3. You should read these Terms and Conditions thoroughly. If you do not agree to be bound by these Terms and Conditions, you shall not access and/or continue to use the Website.
- 1.4. By using our website, you acknowledge that you have read, fully understood and accepted the following:
  - 1.4.1. this Terms and Conditions; and
  - 1.4.2. the Privacy Policy available on EBC’s website.
- 1.5. We use cookies on our website to customize the information and experience displayed on our website according to your preferences. By accessing the Website, you acknowledge that you have agreed to our use of cookies.

## 2. USER’S RESPONSIBILITIES, REPRESENTATIONS AND WARRANTIES

---

- 2.1. As a user of the Website (hereinafter referred to as “User” or “you”), you herein acknowledge, understand, and agree that:
  - 2.1.1. if you are an individual, you are at least 18 years of age, of sound mind and have the legal capacity to enter into a legally binding agreement with us;
  - 2.1.2. if you are a corporation, you are duly incorporated and validly existing under the laws of the country of your incorporation and that you have approved the opening of an account with us by a board resolution certified by the corporation’s officers;
  - 2.1.3. you have the full power and lawful authority to observe and perform the responsibilities mentioned in this Terms and Conditions;

- 2.1.4. you are not accepting the Terms and Conditions under duress and/or otherwise persuaded and/or forced to accept this Terms and Conditions.
  - 2.1.5. You have read, understood, and undertake to comply with these Terms and Conditions, and the documents mentioned in Clause 1.4.
  - 2.1.6. the Agreement, each transaction and the obligations created under them both are binding upon you and enforceable against you in accordance with their terms (subject to applicable principles of equity) and do not and will not violate the terms of any regulation, order, charge or agreement by which you are bound;
  - 2.1.7. except as otherwise agreed by us, you are the sole beneficial owner (i.e. no one else has any kind of legal ownership rights) of all Margin or money you transfer under this Agreement, free and clear of any security interest (i.e. you have not given some form of rights to the money to someone else);
  - 2.1.8. regardless of any subsequent determination to the contrary, trading in the Products is suitable for you and that you are aware of the risks involved with such transactions
- 2.2. Further, the User represents and warrants to EBC not to perform any of the following acts in relation to the Website:
- 2.2.1. upload, post, transmit, and/or otherwise make available any content that shall be deemed as unlawful, harmful, threatening, abusive, harassing, tortious, defamatory, vulgar, obscene, libelous, or invasive of another's privacy or which is hateful, and/or racially, ethnically, or otherwise objectionable;
  - 2.2.2. impersonate any individual or entity, or misrepresent any affiliation with an individual or entity;
  - 2.2.3. forge captions, headings or titles or offer any content that you personally have no right pursuant to any law nor having any contractual or fiduciary relationship with;
  - 2.2.4. upload, post, transmit, or offer any such content that may infringe any patent, copyright, trademark, or any other proprietary or intellectual rights of any other party;
  - 2.2.5. upload, post, transmit, or offer any content that you do not personally have any right to offer pursuant to any law or in accordance with any contractual or fiduciary relationship;
  - 2.2.6. upload, post, transmit, or offer any unsolicited or unauthorized advertising, promotional flyers, "junk mail," "spam," or any other form of solicitation, except in any such areas that may have been designated for such purpose;
  - 2.2.7. upload, post, transmit, or offer any source that may contain a software virus or other computer code, any files and/or programs which have been designed to interfere, destroy and/or limit the operation of any computer software, hardware, or telecommunication equipment;
  - 2.2.8. disrupt the normal flow of communication, or act in any manner that would negatively affect other users' ability;
  - 2.2.9. interfere with or disrupt any EBC's services, servers and/or networks that may be connected or related to our website, including, but not limited to, the use of any device software and/or routine to bypass the robot exclusion headers;

- 2.2.10. intentionally or unintentionally violate any local, state, federal, national or international laws, any rules or regulations of any nation or other securities exchange;
- 2.2.11. stalk or harass another individual;
- 2.2.12. collect or store any personal data in relation to any other user in connection with the prohibited conduct and/or activities which have been outlined in the paragraphs mentioned above;
- 2.2.13. replicate, duplicate, copy, trade, sell and/or exploit for any commercial reason any part of, and/or use of, and/or access granted to the Website;
- 2.2.14. establishing a link in such a way so as to suggest any form of association, approval or endorsement on our part where none of such connection exists;
- 2.2.15. use our domain name or any part of it for any use which is not authorized by EBC;
- 2.2.16. misuse our website by knowingly introducing viruses, trojans, worms, logic bombs and/or other materials that are malicious or technically harmful;
- 2.2.17. decompile, reverse engineer, disassemble, rent, lease, loan, sell, sublicense, or create derivative works from the Website; and
- 2.2.18. use any network monitoring or discovery software to determine the Website architecture, or extract information about usage, individual identities, or users.

### **3. EBC'S RIGHTS AND RESPONSIBILITIES**

- 3.1. EBC reserves our rights to:
  - 3.1.1. suspend, modify, amend and or cancel any access to the Website;
  - 3.1.2. remove and/or delete any such content that would violate the Terms and Conditions, or which would otherwise be considered offensive to other visitors and/or users;
  - 3.1.3. access, preserve and/or disclose member account information if it is requested to do so under any applicable regulations or in good faith:
    - 3.1.3.1. to comply with any legal process;
    - 3.1.3.2. to enforce the Terms and Conditions;
    - 3.1.3.3. to respond any claim that the Website contained content which is in violation of the rights of any third party;
    - 3.1.3.4. to respond requests from customer service; and
    - 3.1.3.5. to protect the rights, property or the personal safety of EBC, its visitors and users, including the public
  - 3.1.4. include the use of security components that may permit digital information or material to be protected, and that such use of information and/or material is subject to the usage guidelines and regulations established by EBC or any other content providers supplying content services to EBC; and

- 3.1.5. prohibit any unauthorised reproduction, publication, distribution and/or exhibition of any information or materials supplied by our Website, despite whether such act was done in whole or in part.

  - 5.5.5. live chat and instant messaging conversations are recorded and may be used for compliance or training purposes; and
  - 5.5.6. conversations on live chat and instant messaging is for your general information only and EBC is not soliciting any action based upon it.

## 6. CONFIDENTIALITY

---

- 6.1. EBC may record all communications between you and us in any forms, including but not limited to telephone calls, emails, faxes, online chatting messages, mobile messages, notice letters ("Information") for quality monitoring, training, regulatory and compliance purposes.
- 6.2. The User and EBC agree and undertake with each other to keep confidential and not disclose to any person, other than that party's professional advisers, directors, officers, or employees, any of the Information provided to it by the other party which in any way relates to this Terms and Conditions and the matters contemplated herein except:
  - 6.2.1. with the prior written consent of the other party respectively;
  - 6.2.2. as may be required by law, any regulatory authority or any stock exchange;
  - 6.2.3. as may be required to investigation or prevention of any illegal activity;
  - 6.2.4. execution venues or any third party as necessary to carry out trading transactions and for purposes ancillary to the provision of the products and/or services;

- 6.2.5. in accordance with the order of a court of competent jurisdiction; or
  - 6.2.6. with the User's consent.
- 6.3. The User agrees not to use any of the information provided by EBC in any way other than to perform any obligations and rights under the Terms and Conditions

## 7. EBC'S INTELLECTUAL PROPERTY RIGHTS

---

- 7.1. You herein acknowledge, understand, and agree that the trademarks, copyright, trade name, service marks, and other EBC's logos and any brand features are and shall remain the sole and exclusive property of EBC and/or its third-party service providers and/or EBC's licensors.
- 7.2. EBC herein has granted you the personal, non-transferable, and non-exclusive rights and/or licence to access to our Website and you undertake not to:
  - 7.2.1. copy, reproduce, translate, duplicate, use, enhance, decompile, decode, disassemble, distribute, sell, transmit, lend, pledge, transfer, alter, tamper, amend, modify, reverse engineer, sub-license, make commercial use or commercially exploit the Website or its source code;
  - 7.2.2. publish, distribute, make available or link to third parties any information derived from the Website;
  - 7.2.3. remove or destroy any copyright notices;
  - 7.2.4. upload or transmit computer virus or other programs to disrupt or destroy the normal operation of the Website;
  - 7.2.5. create or use any domain names, which contains the same words or identically similar words to our domain name;
  - 7.2.6. use any of our trademarks, service marks, logos, or other identifiers or those of any of our third party suppliers;
  - 7.2.7. save to the extent permitted by law, reverse engineer, decompile, disassemble, or access the source code of the Online Facility.
  - 7.2.8. display and/or use in any manner EBC's logo or marks without obtaining EBC's prior written consent; and

## 8. INDEMNITY

---

- 8.1. Save as otherwise expressly provided herein, you agree and undertake with EBC to indemnify and hold EBC, EBC's associates, related companies, third-party service providers, licensors harmless from and against any damage or loss suffered, incurred or sustained by that EBC, or to which that EBC becomes subject, resulting from, arising out of or relating to any misrepresentation, breach of warranty or non-

fulfillment of or failure to perform any covenant or obligation contained in the Terms and Conditions by you.

- 8.2. You acknowledge that this responsibility shall include but not limited to any legal and administrative costs and expenses incurred.

## 9. GOVERNING LAW AND JURISDICTION

---

- 9.1. This Terms and Conditions shall be governed by and construed in all respects in accordance with the laws of Saint Vincent and the Grenadines, and the parties agree to submit to the non-exclusive jurisdiction of the courts of Saint Vincent and the Grenadines.
- 9.2. Nothing in this Terms and Conditions shall limit or prohibit EBC's right to initiate legal proceedings against the User in other courts of competent jurisdictions, and the legal proceedings in one or more jurisdictions shall not preclude the initiation of legal proceedings in any other jurisdiction.

## 10. MISCELLANEOUS

---

- 10.1. Without prejudice to any other rights or remedies a party may have, each party acknowledges and agrees that damages may not be an adequate remedy for any breach of this Terms and Conditions and the parties shall be entitled to the remedies of injunction, specific performance, and other equitable relief for any threatened or actual breach of this Terms and Conditions.
- 10.2. No exercise or failure to exercise or delay in exercising any right, power or privilege vested in any party shall operate as a waiver thereof or of any other right, power or privilege, nor shall any single or partial exercise of any right, power or privilege preclude any other or further exercise thereof or the exercise of any other right, power or privilege. Any waiver by a party of a breach of any provision of this Terms and Conditions shall not be considered as a waiver of any subsequent breach of the same or any other provision hereof.
- 10.3. If any provision of this Terms and Conditions or the application thereof to any situation or circumstance shall be rendered invalid or unenforceable, the remainder of this Terms and Conditions shall not be affected, and each remaining provision shall be valid and enforceable to the fullest extent and EBC has the option to either remove the invalid or unenforceable provision or to replace the invalid or unenforceable provision with valid and enforceable provision.
- 10.4. Unless otherwise provided, the rights and remedies provided in this Terms and Conditions are cumulative and not exclusive of any right or remedy otherwise provided by law.
- 10.5. The official language of this Terms and Conditions shall be English. EBC may provide this Terms and Conditions in other languages for information purposes only and in the event of any inconsistency or discrepancy between the English version of this Terms and Conditions and any other language version, the English version shall prevail.
